



Initial Appointment: During this appointment, you will speak with one of ReleafMD's medical doctors about your medical condition and how you may qualify for medical marijuana.

- ◆ Please be open! Share all of your concerns with the doctor so that we may advise you the best way for your medical condition and comfort level.
- ◆ MMJ is not a "one size fits all" and may require some time to find the right level of care that is best for you.
- ◆ We suggest you keep a small journal of your time, doses and routines until the right balance is found for you.

Bring this journal with you on your next follow up appointment.

State Application: During your initial visit the staff has assisted with creating your patient profile and applying to the state.

- ◆ The annual state fee is \$75 (paid once per year). Once payment is submitted, you will be given your patient login 45 days prior to expiration to reapply.
The office does not have record of your login and will not send reminders.
- ◆ The state's review of your application, new or reapplying, can take about 10 business days (more or less) and will send an email of your approval or denial.

If denied, the email will provide the reasoning and with a correction and you will be able to log back into the queue for approval.

- ◆ This is done through your patient portal and NOT in the office.
- ◆ Once approved, you may print your approval email and with your I.D., you may go to the dispensary and obtain your medication. You do not have to wait the additional time for the physical card to arrive in the mail.
- ◆ The username will be the email address you provided, and your password will be the 10-character password you created.

If you have issues logging in, please select "forget password". You will receive an email with a temporary password that will allow you to reset a new password.

- ◆ Remember this password will need to be 10 characters long and contain at least one capital letter, lowercase letter, number and special character. Select ***"remember me"*** to save to your device.

A. Please note this office has no control over the state approving or denying your application.

B. The card will be sent to your address not the office.

Follow-up Appointment: The state mandates you must see the doctor in person every 7 months. ReleafMD will schedule your follow up appointments at the time of each visit.

- ◆ ReleafMD schedules the follow up appointments in 6 months to ensure we stay in compliance with the law; allowing a couple of weeks of flex in case of reschedule.
- ◆ The follow up appointment is the best time to discuss what is helping and what is not so the doctor may help guide you.
- ◆ We have a very knowledgeable staff that may be able to answer some of your questions but please understand they are not doctors but want to see you succeed..

Reschedule: If you are unable to attend your appointment please call our office at (813) 651-3492 and we will reschedule you for the next available appointment that works for you. We appreciate a 24-hour notice.

A no-show to your appointment will lead to an additional \$25 fee added to your next appointment and the possibility of your recommendations being rescinded.

Dispensaries: Here is a link to a list of the dispensary locations throughout the state of Florida.

- ◆ You may also use Google Maps to find the closest one to you by searching "dispensary".
- ◆ As marijuana is not federally mandated, it is important to not cross the state lines with any products that contain THC.
- ◆ It is illegal to consume your medication in public and to share with any other individuals.

Recommendations: Recommendations are not prescriptions, rather what the doctor recommends for your medical marijuana treatment.

- ◆ The patient portal on the state site allows you to view what has been recommended, what you have purchased, how much you have purchased and where it has been purchased from.

It is highly recommended that you to get familiar with the site to better plan out your medicinal purchases.

Referrals: We appreciate you referring your friends, family and co-workers to us. Please bring the names of people you refer for a chance to have your next appointment discounted.

To qualify as a referral the individuals must become patients of ReleafMD; have completed an appointment and are listed under Dr. Kelly King in the Medical Marijuana Use Registry.
